Getting Military Records from NARA/NPRC in

I have been saying for some time now that I am not going to do presentations that just rattle off a bunch of websites.

Instead, I am going to give you some facts and best practices to follow for the subject.

This subject has been talked about for many years without any real details on how to apply for DOD papers on your ancestor.

As typical with all Federal Websites the NARA sites are full of rules and nonsense and gobilty gook. Written by PHD's and Scientists.

I do not have anything against them personally, but they need to make it easier for the average person to navigate the website..

To request military records for a deceased relative from St. Louis, you can use Standard Form 180 (SF-180), notes archives.gov. You can mail or fax the form to the National Personnel Records Center (NPRC) in St. Louis.

How to request records.

- 1. Complete the SF-180
- 2. Include as much information as possible
- 3. Attach copies of any service documents you have
- 4. Include proof of death, such as a copy of the death certificate
- 5. Mail or fax the form to the NPRC
- Requesting Copies of Military Service Records thru NARA.

Mail.

Send a written request to the National Personnel Records Center, 1 Archives Drive, St. Louis, MO 63138

For Civilian Conservation Corps (CCC) records, use Standard Form 14136

For medical records, use NA Form 13042

In person.

Schedule an appointment to visit the Archival Research Room at the National Archives at St. Louis.

The research room is open by appointment only, Monday–Friday, 9 a.m.–4 p.m.

Other options.

Use the eVetRecs website to request records.

Hire an independent researcher to examine the records on your behalf.

Military personnel records

Military personnel records are open to the public 62 years after the service member's separation from the military.

There may be a fee for archived research, depending on the individual case need.

This is where to go for Coast Guard and Merchant Marine Records.
